2023-2024 FEES

The Extended School Care (ESC) program offers Westminster Catawba Christian School students fun-filled times in a structured, enrichment-oriented environment. The program provides students with many opportunities including active sports, creative arts and crafts, story times, movies, and much more. ESC exists to maintain a secure Christian environment for students Infant through 8th grade during the hours between school and home.

The Extended School Care program is staffed by qualified teachers and assistants. Dedicated classroom space provides facilities for several multi-grade divisions. In grades one through eight, homework assistance is available and students are encouraged to complete assignments during the designated time.

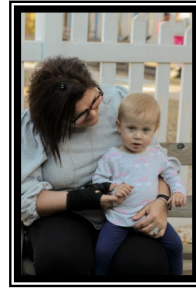
WCCS authorizes supervision of students from 7:00 a.m. until 6:00 p.m.

Early Arrival: Any student arriving between 7:00-7:30 a.m. is considered an early arriver, resulting in a fee. For drop-in care, arrangements **MUST** be made in advance through the ESC Director to ensure space availability.

AfterSchoolCare: This service is available on a regular or drop-in basis from Dismissal-6:00 p.m. Students registered for regular care are charged based on a fixed monthly fee. Students that use the drop-in care pay an hourly rate and **MUST** make arrangements in advance through the ESC Director to ensure space availability.

During Extended School Care, students will participate in an appropriate balance of the following activities:

- Snack time
- Homework
- Recreation
- Creative expressions
- Physical activity



ENROLLMENT

Enrollment is completed online at the same time as class enrollment. Please consider the following guidelines when choosing your registration:

- ESC fees are billed automatically through FACTS and are due by the first of the month. Any invoices not paid by the 10th of the month are considered late, and a \$20.00 late fee will be charged. Invoices for drop-in, late, and no notice fees will be emailed and accounts will be charged automatically through FACTS.
- Credit is not available for days absent.
- Teacher Workdays are included for those students who are registered and attend on a 4/5 day monthly basis.
- Sixth through eighth grade students will have Extended School Care at the Upper Campus each afternoon after school and must be picked up from that location.

Early Arrival Infant-5th Grade

7:00-7:30 a.m. (7:30-7:55 a.m. no additional charge)
\$60 a month/family
\$7.00 a day/per child

After School Care (Monthly fee)

Infant– Two Year After School

Dismissal-6:00 p.m.
5 days/week: \$340/month/child

3K-8th Grade After School

Dismissal-6:00 p.m.
4 or 5 days/week \$280/month/child
3 days/week \$220/month/child
2 days/week \$170/month/child

Drop-In Charges (Hourly Fee)

\$14.00 per hour/child

These are hourly charges for an hour or a fraction of an hour. **Drop-ins are required to make arrangements in writing or by voice mail to the ESC Office at 366-6462 .**

Late Pick-up Charges

Late pick-up fees are charged by the minute after 6:00 p.m.

1 - 10 minutes	\$1/minute
11 - 20 minutes	\$2/minute
21 - 30 minutes	\$3/minute
30 - up minutes	\$5/minute

For example, a child picked up at 6:13 p.m. would be charged \$16 (\$1 for minutes 1 through 10 and \$2 for minutes 11 through 13).

No Notice Fee

A fee of \$20 will be charged (in addition to the late fee and hourly drop in rates) for all students that drop -in/or are picked up late from ESC without receiving prior 24 hour authorization from the ESC Director.

Billing

ESC fees are billed automatically through FACTS and are due by the first of the month. Any invoices not paid by the 10th of the month are considered late and a \$20 late fee will be charged. Invoices for drop-in, late, and no notice fees will be emailed and accounts will be charged automatically through FACTS.
